3. As of the date on which this action was first filed, USBNA was trustee, securities

administrator, paying agent, and/or calculation agent (as named in such role or as successor to the

named party) for one-hundred and fifty-six of the two-hundred and seventy residential mortgage-

backed securitization trusts at issue in this proceeding (the "Settlement Trusts"), as further

specified on Exhibit A to the Petition at NYSCEF No. 2.

4. Since the filing of this action, parties to certain of the Settlement Trusts have agreed

to resolve their competing claims without further judicial intervention, leading many of the

Settlement Trusts to be severed from this action. Following the severance of these Settlement

Trusts, USBNA remained trustee, securities administrator, paying agent, and/or calculation agent

(as named in such role or as successor to the named party) for thirty-seven of the sixty Settlement

Trusts still at issue in this action (the "Remaining USB Trusts").

5. In 2022, USBNA transferred substantially all of its corporate trust business to

USBTC, a wholly owned subsidiary of USBNA. As a result of this transfer, USBTC has succeeded

to all transaction roles (including but not limited to trustee, securities administrator, paying agent,

and/or calculation agent) for twenty of the thirty-seven Remaining USB Trusts specified on Exhibit

1 to the contemporaneously filed proposed Ex Parte Order Substituting Party and Amending

Caption (the "Transferred Remaining USB Trusts"), and USBNA no longer fulfills such roles for

the Transferred Remaining USB Trusts.
